**Sub: Amendment to the Tender Enquiry Document**

The following Amendments are hereby made to above referred tender:-

<b>1. SECTION-1, DETAILED SCOPE OF WORK AND TERMS &amp; CONDITIONS</b>
--

**For:-**

35. The Agent shall furnish a Performance Bank Guarantee (PBG) for Rs. 1,00,00,000/- (Rupees One Crore only) in favour of the HLL Lifecare Ltd, Noida for the due performance of the agreement within 15 days of issue of Letter of Award failing which the EMD will be forfeited. An agreement will be executed with the successful tenderer after obtaining the PBG. The PBG will be forfeited for failure of the successful bidder to perform the contract.

**Amended to Read as:-**

35. The Agent shall furnish a Performance Bank Guarantee (PBG) for Rs. 25,00,000/- (Rupees Twenty Five lakhs only) in favour of the HLL Lifecare Ltd, Noida in the given format within 15 days of issue of Letter of Award failing which the EMD will be forfeited. In case of failure in performance of contract by the successful bidder, the PBG will be forfeited. Apart from PBG, an Indemnity bond (on Rs.500/- Stamp Paper) in the given format has also to be submitted by the successful tenderer within 7 days of issue of Letter of Award.

<b>2. SECTION-2 ELIGIBILITY CRITERIA</b>
--

**Added clause:**

24. Should not have the record of poor performance such as abandoning work, not properly completing the contract, termination, financial failures/ weaknesses etc. In any case if it is observed, it will be considered as a reason for rejection. HLL/ HITES have the full right to assess the performance of the work by the bidder and the decision shall be binding upon the bidder.

<b>3. SECTION-3 PRICE BID</b>
-------------------------------

**Added Point:**

**Exception:** In case of sea shipments, DO charges/Shipping Line Charges and Seaport Charges will be reimbursed by HLL/HITES at actual on submission of original receipt/Proof along with the bills. All the charges including demurrage/penalty charges, if any applicable shall be paid initially by the Agent. However, if the delay is not attributable to the agent due to specific reasons, upon submission of proof acceptable to HLL/HITES, the same shall be reimbursed.

**Added point:**

The expected value of shipment for clearance during the contract period is approximately Rs.1200 Cr. However, this is a mere indication only and that may go much lesser than or more than the above mentioned value, since it depends on client approvals. Hence, any claim/ representation in later stage based on the indication given is not claimable / acceptable.

**All other contents of the tender enquiry including terms & conditions remain Unaltered.**
