1. Tender Inviting Authority:

HLL Infra Tech Services Limited, (HITES) on behalf of Ministry of Health and Family Welfare, Govt. of India, invites bids from firms / contractors of repute in two bid system for “Supply and Fixing of Hostel Furniture” for MBBS (2nd Year) for AIIMS, Bibinagar, Yadadri Bhongiri District, Telangana – 508126.

2. Insurance:

i. The supplier shall make arrangements for insuring the goods against loss or damage incidental to manufacture or acquisition, transportation, storage, delivery, installation & handing over in the following manner:

ii. The supplier shall be responsible till the entire stores contracted for arrive in good condition at destination. The transit risk in this respect shall be covered by the Supplier by getting the stores duly insured for an amount equal to 110% of the value of the goods from “warehouse to warehouse” (consignee site) on all risk basis. The insurance cover shall be obtained by the Supplier making the consignee as beneficiary and should be valid till 3 months after the receipt of goods by the Consignee.

3. Payment: The payment shall be released by HITES on behalf of AIIMS, Bibinagar upon satisfying the General Terms and Conditions and receipt of goods in good condition and upon the submission of the following mandatory documents by the seller to HITES project office, AIIMS, Bibinagar, Yadadri Bhongiri District, Telangana - 508126 along with delivery of items at site:

i. One Original and three copies of supplier’s invoice showing consignee name, address, contract number, goods description, quantity, unit price and total amount and invoice shall be raised in the name of **AIIMS, Bibinagar, Ministry of Health & Family Welfare, Govt. of India.**

ii. CRC issued by the authorized representative of the consignee/HITES Project in charge;

iii. Two copies of packing list identifying contents of each package;

iv. Inspection certificate,

v. Manufacturer’s/Supplier’s warranty certificate

vi. Insurance certificate

vii. Final Acceptance Certificate issued by the authorized representative of the consignee/HITES Project in charge;

4. The successful bidder has to submit colour samples and obtain the approval from the buyer before dispatch of goods.

5. Liquidated Damages: if the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the contract, the Procurement agency shall, without prejudice to its other remedies under the Contract, deduct from the contract prices as liquidated damages, a sum equivalent to the 0.5% percent of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the 10 percent of the value of delayed Goods. Once the maximum is reached, the Procurement agency may consider termination of the contract.
6. Packing: The supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination at consignee site.
7. The ownership of the goods belongs to MoH&FW / AIIMS, Bibinagar.
8. The prices quoted by the bidder shall remain firm and fixed during the currency of the contract and not subject to variation on any contract.
9. The buyer reserve the right to cancel the bid in part or full without assigning any reason and liability on the buyer.
10. Independent External Monitor (s)
 - i. HITES has appointed Sh. A.K. Arora, Ex-DG, Indian Defense Service of Engineers as Independent External Monitor(s) (hereafter referred to as IEM(s)) for this pact in consultation with the Central Vigilance Commission. Contract details of IEM is as below:
