#### 2 INTRODUCTION:

#### 2.1 Brief Particulars of the Work

#### 2.2 Eligibility Criteria & Disqualification:

#### c) <u>Documents Comprising the Bid</u>

  - Nearest Airport from the Project Site: Rajiv Gandhi International Airport, Hyderabad being the nearest airport is at a distance of 63.3km (60 minutes approx.) The site is also accompanied by Bus Stops located close to the site.


