3.3 RIGHT TO ACCEPT/REJECT ANY OR ALL APPLICATIONS

HITES reserves the right to enter into agreement with as many bidders as it deems fit. Offers / Bids received after due date and time shall be summarily rejected. 3. ELIGIBILITY CRITERIA

- 1. The company should have a minimum average annual turnover of Rs. 1 Crore in last 3 financial years.
- 2. The firm should have Three (03) years' experience in the field of Event Management. The firm should have successfully executed at least 01 mega international events of stature in last 03 years, (relevant documents to be attached).
- 3. The tenderer / firm / agency / company would be required to submit the proof in support that which is an income tax payee along with PAN.
- 4. The tenderer / firm / agency / company should have valid GST registration and attach a copy of the same with the technical bid.
- 5. The tenderer should submit an undertaking cum affidavit with the technical bid that he or his firm has not been blacklisted by any of the organization / government department as on the date of submission of the bid.
- 6. The bidder should have organized events of similar nature and scale for a Govt. of India Ministry/Department/PSU/State Government in last three years.
- 7. Sub-contracted or sublet job on their name will not be considered towards eligibility. The agency which has the work order shall only be considered for this purpose.

5. Scope of work

- **2.** Each service provider considered, acceptable on evaluation of their credentials and who fulfill the requisite criteria as stated above and on the basis of the presentation made by the companies before the screening committee. The decision of HITES shall be final and no correspondence on rejection will be entertained.
- **3.** Other terms & conditions for the supply of service for informative services would be as per the tender/quotation/enquiry issued from time to time which would be event specific.
- **4.** HITES reserves the right to withdraw/cancel the bid document at any stage.
- **5.** HITES reserves the right to reduce/increase the design/design elements or alter the design/design elements and decision of HITES in respect of this shall be final and binding on the selected bidder.
- **6.** The Application should be submitted in scan copy neatly typed (preferably in English language computer generated) and free from over writing/cutting) in the prescribed tender form and after going through the terms and conditions, which may be downloaded from :
- **7.** Correcting fluid should not be used in any case. Alterations unless legibly attested by the tenderer, shall disqualify the tender.

- **8.** All the documents should be serially numbered and signed by the tenderer as per EOI.
- **9.** Application must clarify whether the vendor is Company/ Partnership/ Proprietorship/LLP etc. and also submit supporting documents such as Articles & Memorandum of Association or Partnership Deed etc.
- **10.** Proof of satisfactory supply of services in Government/Semi Government/PSUs /corporate houses and related experience during the last 03 years with proof of completion, if any, be enclosed.
- **11.** If the service provider is registered or on the panel of other Government organizations/non-Government Organization, it should be clearly mentioned and supported by certificates/letters.
- **12.** The Bid/Tender process validity for a period of 180 days from the date of publishing/submission of the EOI at e-procurement or department website. This tender is only single cover.
- **13.** The Initial contract period will be one year extendable further on satisfactory performance. The contract shall come into effect on the date of signing the contract or work order (whichever is earlier) herein after referred to as effective date.

FINANCIAL:

- **14.** Service Provider shall submit documents supporting its financials and other relevant registrations like GST, PAN No.etc.
- **15.** In case of deficiency in service, HITES reserves its right to make deduction from the security deposit or running bills besides blacklisting the Company
- **16.** The Event Management Agencies are required to submit an EMD of Rs. 1,00,000/-(Rupees One Lakh only) through online mode as per the bank details provided in this EOI, which is to be paid upon issuance empanelment letter only.

PENALTY:

- **17.** The HITES reserves the rights to suspend the tender/ reject any application, if found incomplete or if information provided by the agency/firm is inconsistent and inaccurate. The date of declaration of qualified service providers will be at the discretion of the CEO/Competent Authority of HITES.
- **18.** In the event of any lapses in the application form or any incidents, fraudulent information the Competent Authority may black list the service provider by appointing a committee. The Committee shall examine the issue in depth and give its recommendation to the Competent Authority with specific period of Two Years of black listing.
- **19.** The service provider shall be intimated after giving due opportunity of the lapses and its reasons affecting interests of company.
- 20. Empaneled agencies are required to appear and participate in all the limited tenders

and their presentation, called by HITES, as and when required. If any agency fails to appear regularly in 03 consecutive limited tender's up to the stage of Power Point Presentation (PPT), the said agency will be blacklisted/ debarred for 02 years and their security deposit will be for forfeited.

LEGAL:

- **21.** Service Provider shall submit an undertaking along with application that it shall abide by all the laws of India including Copyright, Trademark etc. during the event and shall also take applicable permissions e.g. Pollution, Fire, Police etc. And shall always keep HITES indemnified in all circumstances.
- **22.** All the disputes shall be subject to the Jurisdiction of Delhi Courts.
- **23.** HITES reserves the right to accept / reject any or all the e-tender/s in part or full without assigning any reason.

FORFEITURE:

Security deposit shall be forfeited in following cases:

- **24.** Vendor does not execute the agreement after acceptance of tender, within the specified time.
- **25.** Vendor fails to appear for the tender's stage of Power Point Presentation (PPT), when called by HITES.
- 26. Corrupt, fraudulent and unethical practices: HITES will reject a proposal for award and also may debar the bidder for future tenders in HITES, if it is found that the bidder is engaged in corrupt, fraudulent or unethical practices in competing. Here: "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the process of contract evaluation, finalization and or execution and "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Purchaser of the benefits of free and open competition, "Unethical practice" means any activity on the part of bidder by which bidder tries to circumvent Empanelment process in any manner. Unsolicited offering of discounts, reduction in financial bid amount, upward revision of quality of goods etc. after opening of first bid will be treated as unethical practice.

CONFIDENTIALITY:

Bidder/contractor shall keep all the knowledge and information (which is not within the public domain), which may be acquired during the carrying out of this assignment, strictly confidential for all times and purposes. All documents or software submitted by the bidder in the performance of the services shall become and remain the property of HITES.

SETTLEMENT OF DISPUTE AND ARBITRATION:

Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning, operation, effect, interpretation of the contract or breach thereof which parties are unable to settle mutually, the same shall be referred to Arbitration as provided hereunder. A party wishing to commence arbitration shall specify all the points of disputes with details of the amount claimed to be referred to arbitration at the time of invocation of arbitration and not thereafter. The dispute shall be referred to arbitration by a Sole Arbitrator to be appointed by **HITES.**

The cost of arbitration shall be borne by the respective parties. The cost shall inter-alia include the fees of the arbitration(s) as per the rates fixed by the arbitrator from time to time.

The Arbitration shall be held at Delhi, the place from where the contract has been awarded. The Arbitrator(s) shall give reasoned and speaking award and it shall be final and binding on the parties. Subject to aforesaid, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof shall apply to the arbitration proceedings under this clause.

INDEMNIFICATION:

The Event Management Companies agrees to indemnify and hold the HITES harmless from and against any and all costs, losses or expenses, including reasonable attorneys' fees, that the HITES may incur by reason of any third-party claim or suit arising out of or in connection with company's failure to perform pursuant to this contract, as well as the negligence, gross negligence, or intentional misconduct of Organizer, its employees, agents and representatives, contractors or subcontractors, including the employees and representatives of said contractors or subcontractors.

GOVERNING LAWS AND JURISDICTION OF CONTRACT:

The laws applicable to the contract shall be the laws in force in India. The courts of New Delhi shall have exclusive jurisdiction in all matters arising out of or relating to the contract.

FORCE MAJEURE.

- 1. Force Majeure is herein defined as any cause which is beyond the control of the Agency or Company as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:
- 2. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
- 3. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, and embargoes.
- 4. Provided either party shall within 15 (fifteen) days from the occurrence of such a cause

notify the other in writing of such causes, along with proof of such occurrences.

5. The Agency or HITES shall not be liable for delays in performing its obligations resulting from any force majeure cause as referred to and/or defined above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time at the sole discretion of HITES.
