INTRODUCTION/ BACKGROUND

I. Appointment of Consultants

A bidder can quote in one category only. Bidders quoting in more than 1 category will be disqualified automatically. Bidders however can quote in more than one class under a category.

II. CLASSES OF APPOINTMENT

1. The Consultants will be empanelled in following classes, based on their experience and number and types of projects of the relevant field handled by them:

- 2. For appointment in more than one class in a category, the Bidders need to quote accordingly in the Financial Bid along with required processing fees.
- 3. A non-refundable processing fee of Rs.10000/- (Rupees Ten Thousand only) inclusive of GST per Class under a Category should be enclosed with all applications by NEFT/RTGS in Bank a/c of HITES. Bids without processing fees, shall be summarily rejected.

- 1. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for appointment.
- 2. The appointment shall be valid for a period of 3 (three) years. The panel may be curtailed/ extended further at the discretion of HITES.
- 3. IIT/NIT/ Govt. Engineering colleges are exempted from qualifying based on the above eligibility



criteria.

- 4. Applicants who have successfully provided Consultancy Services for Works/ Projects of values mentioned above, during the last 5 years and fulfill specified minimum criteria shall be eligible to apply.
- 5. Consultant(s)/Firms having experience in designing Green Buildings as per GRIHA norms or equivalent recognized international norms should give details of such works carried out by them in the last five years.
- 6. HITES is committed to provide world Class healthcare and related infrastructure in the country, Consultants having international experience should highlight this aspect clearly with details and testimonials for such works carried out by them at international level.
- 7. The Application should be on the prescribed form. All Annexure duly completed should be submitted. The Annual turnover of the Consultants/firm and profit and loss statement by way of Professional Fees for Consultancy for the last three years, duly audited by a Charted Accountant, should be submitted. Certified copies of Award letters, completion certificates etc should be enclosed.
- 8. Summary of regular/permanent professional employees and key Personnel including the nature of specialization, qualifications and experience should be enclosed along with certificates.
- 9. Applicants should give an undertaking certifying that the firm has not been blacklisted by any Govt./ Local bodies/ PSUs.
- 10. Consultant(s)/Firms may be called for a presentation before the designated committee of HITES which will form part of this qualification.

3. Instructions to Individual consultants

- 1. Eminent technocrats willing to work as Consultant to HITES can apply for appointment under this RFP in different categories.
- 2. They have to submit their credentials in the prescribed formats. In addition to this, they may have to make a presentation before the designated committee of HITES which will form part of this qualification.
- 3. They will have to enter into agreement with HITES for the successful performance of the assignment given to them.
- 4. They should be below 60 years of age and in exceptional cases up to 65 years.
- 5. The role of the consultants will be recommendatory only and the final decision will be taken by HITES.
- 6. Necessary working space for the consultant will be provided at the discretion of HITES. No local transportation will be provided for the assignment



7. The work of the consultant will be subject to scrutiny by HITES as per terms and conditions of RFP/ agreements.

I. Instructions & Guidelines for Submission of Application Form for Appointment of Consultants

- 1. Appointment documents shall be downloaded from our website at www.hllhites.com and CPP Portal https://etenders.gov.in/eprocure/app.
- 2. Bid shall be submitted online on CPP Portal <u>https://etenders.gov.in/eprocure/app</u> on or before the date & time mentioned in the Bid Document.
- 3. The bid shall be submitted online only as per the enclosed format (s) along with Annexure I to XI, Self-attested documentary proof(s) in respect of the details furnished in the application form shall be submitted along with the application. The intending applicants shall also submit the list of such projects where due to any disputes litigation/ arbitration was invoked and/ or the consultancy services were abandoned/ suspended by the consultant(s). Suppression of any information in this regard may lead to cancellation of appointment of the Firm/ Consultant(s) concerned, if such information comes to the notice of HITES after appointment. Incomplete applications will be summarily rejected.
- 4. The application shall be signed by the Director of the firm or official who has Power of Attorney. All pages of the documents shall be signed/ sealed and to be uploaded online on CPP Portal. ALL PAGES OF RFP DOCUMENT SHALL ALSO BE SIGNED AS A TOKEN OF ACCEPTANCE OF THE CONDITIONS.
- 5. In case an application is found suitable for appointment in class lower than the one applied for, the appointment may be done in the eligible category in respect of such candidate(s).

II. General Terms and Conditions

1. No change in status of firm without prior approval:

- a. Empanelled Consultant / Firm shall not enter without any fresh partnership or change of constitution without prior approval of the empanelling authority. In case they want to enter into any fresh partnership or change the constitution, they must intimate in advance full details of the intending partnership / Draft Memo & Article of Association of company. Any change in status of the empanelled consultant / firms will render the firm / Architects liable to be removed from the empanelled list of HITES.
- b. If a firm is converted & dissolved into two or more firms, the new firm(s)/Consultant shall have to apply afresh for appointment based on experience and other qualifying criterion of separate entity, as & when the proposals for appointment are invited again.
- c. Change in permanent address shall have to be intimated within one month. All banks certificates, experience certificates etc. should bear one addresses, otherwise the same shall not be accepted.
- d. The Appointed Consultant / Firm shall abide by the terms & condition of the appointment & contracts. The consultant shall timely & satisfactorily execute the contracts.



e. Empanelling authority shall have right to take action against the Empanelled Consultant / Firm for misconduct/ lack of professional deliverance of services, & fraud etc. The decision of HITES shall be final & binding on the Empanelled Consultant / Firm. Following action in this regard of empanelled consultant shall make him/them liable for the following disciplinary actions:-

Demotion to lower category:

The consultant may be demoted to lower category if he/they:

- Fail to execute contract or execute it unsatisfactorily or is proved to be responsible for defects in designs / estimates / specifications of the work.
- Is no longer in possession of adequate equipment, technical personnel or financial resources.
- Is litigious in nature, or
- Violates any important conditions of contract or
- Has adverse performance repeat or
- Is responsible for a conduct, which may justify his demotion to lower category.

Removal from empanelled list:

Empanelled Consultant / Firm may be removed from the empanelled list, if he/they:

- Is / are found to have given false particulars at the time of appointment or
- Has / have changed constitution of firm without prior approval of empanelling authority or
- Has changed permanent address without intimation to empanelling authority or
- Is / are declared or in the process of being declared bankrupt / insolvent, winding up / dissolved partnership / partitioned.
- Persistently default in settlement of statutory taxes / regulations.
- Has indulged in any type of forgery or falsification of records or
- Is/are convicted by a court of law, or
- Has quoted for a tender under two or more firms where he/they is/are Partner/Director /Owner.
- Fail(s) to abide by the terms and conditions of appointment as given in RFP, or
- Cease(s) to fulfill eligibility criteria based on which appointment was done, or
- Fail to carry out work after the same is awarded to them and has, on one or more than one occasion, failed to execute a contract or has executed it unsatisfactorily
- 2. The consultant shall furnish at regular intervals by HITES his/their performance report in prescribed Performa / and manner for reference & record of HITES.
- 3. Consequent up on review by empanelling authority, if a consultant / firm is found guilty of malpractice, criminal conduct or non-observance of appointment rule Empanelled Consultant / Firm shall be liable to be weeded out from the approved list of HITES.
- 4. HLL may modify, add and / or delete and / or change any of the above provision / rules without any notice and the same shall be binding on the consultant empanelled with HITES.

5. Payment of Remuneration:



The HITES agrees to pay to the Empanelled Consultant / Firm the fee for the professional services to be rendered by him as herein above described:

- The payment of fees shall be made on the area basis with respect to total area of building of the respective project of HITES for whom the Empanelled Consultant / Firm is appointed. The area for the purpose of payment shall be the plinth area of buildings as per latest CPWD PAR norms.
- Following areas shall not be reckoned with for working out the plinth area and their cost shall be deemed to be included in fees payable to the Consultant.
 - i. Retaining walls, stability of slopes etc.
- ii. Building approach /drop off including sub-base, KERB Stone, Pavers, Toe Wall, Railing, Road/pavement and external development.
- iii. External works such as pump rooms, underground structures including Overhead/UG Tanks/Surface Tanks, STP/ WTP etc.
- iv. The culverts for storm water/ rain water along the road alignment
- The interim payment shall be made on "Pro rata basis" and shall be worked out on the percentage of work done out of total scope of work under their activity/item. The payments made to the consultants shall be subject to deductions as per Indian Tax Laws.
- The above fees mentioned shall be deemed to be inclusive of fees payable by the Consultant to his any other sub-consultant and associates, needed to accomplish the job and nothing extra, whatsoever, shall be payable.
- The said fee shall be inclusive of all the direct and indirect taxes including GST, duties/ cess to be paid by the Consultant, any other fee/ expenditure incurred by the Consultant.

III. Conflict of Interest

- 1. HITES requires that consultants should provide professional, objective and impartial advice and at all times hold the client's interest paramount, strictly avoid conflicts with other Assignment/ jobs or their own corporate interests and act without any consideration for future work. The consultant and any of their affiliates shall be considered to have a conflict of interest and shall not be hired under any of the circumstances given below:
 - a. Conflicting activities or assignment i.e. providing goods or works or assignment other than consulting assignment.
 - b. Conflicting relationship i.e. business/relationship with a member of client's staff involved in the job.
 - c. The bidder shall not employ any staff from current or past or retired employees of MoHFW/ HLL/ HITES in any capacity unless such employee has completed at least one year post retirement/resignation or has obtained N.O.C from the concerned departments.
 - d. The consultants shall be required to observe the highest standard of ethics during rendering of professional services.
- 2. Incomplete Applications will be summarily rejected. HITES reserves the right to accept or reject any application without assigning any reason.

2. The marks shall be decided by a duly constituted Committee on the basis of predetermined criteria and where it is not possible to do so, based on their own judgment. The evaluation carried out by the said Committee shall be final and binding.

- 3. Only those applicants who secure overall score of 75% shall be empanelled.
- 4. Submission of satisfactory completion certificate from previous clients is essential. Bidders are requested to submit such certificate in their own interest, if possible.
- 5. HITES reserves the right to modify the criteria and take own decision if so required.



- 6. Financial Bid: As already mentioned the Financial Bid should be submitted online
- 7. The financial Bid shall be submitted by the bidders in conformity with uploaded format. Financial Bid submitted in any other format will stand disqualified & rejected. Lowest financial Bid (Fm) shall be given a financial score (Sf) of 100 points. The financial score of the other financial Bids (Fo) shall be computed as follows:

Sf = 100 x Fm (Lowest financial Bid) / Fo (Other financial Bid)
