OPENING OF TENDER

1.4.1 The proposals will be opened, and will be evaluated as per Qualification/ Eligibility criteria mentioned in TENDER. Failing to qualify Qualification/ Eligibility criterion shall lead to rejection of the Proposal and Bidder.

Business Proposal:

Proposal for setting up E- vehicles charging & e-Bike/e-Cycle/ Cycle (non-motorized) Transportation Sharing System stations at various locations on the Government owned land. Civil Division has been explored possibilities for tapping this increasing business of setting up E-vehicles Charging & e-Bike/e-Cycle/Cycle (non-motorized) Transportation Sharing System stations which involves Civil, Electrical works & procurement of advertising at the sites to be allocated by HITES at no cost to HITES and then collecting the revenues towards charging of a fee from users of E-vehicles, subscription & user fees from e-bike/e-cycle/cycle users, as well as revenues from charges on display of advertisements through hoardings etc. at such sites.

- a. As per this HITES will provide bare space for installation of E- Vehicles Charging & e-Bike/e- Cycle/Cycle (non-motorized) Transportation Sharing System Station and battery swapping stations and ensure necessary system re-enforcements with parking concessionaire and other authorities for installation of Public Charging Station (PCS) as and when required, at mutually agreed locations.
- b. The selected agency or concessionaire will be responsible for Procurement of Charging Units and related infrastructure at agreed locations. All Capital Costs of PCS includes cost related to the installation of EV Supply equipment (EVSE) and related infrastructure such as charger management system (CMS), meter and meter box, and accessories such as canopy, LED screen, CCTV camera, barricading etc. and other operating costs i.e. payment gateway charges, insurance premium etc.
- c. The permission granted by HITES shall remain in force for a maximum period of 120 months (10 years) from the effective date of issue of permission letter.

The terms and conditions of this TENDER shall be as under:

Technical Definitions:

a. Electrical Vehicle Supply Equipment (EVSE): Electric Vehicle Supply Equipment (EVSE) includes the electrical equipment external to the electric vehicle that provides a connection for an electric vehicle to a power source for charging and is also equipped with advanced features like Smart Metering, Cellular Capability and Network Connectivity.

b. EV Charging Station: For this TENDER, EV Charging Station is defined as a station with a set of Electrical Vehicle Supply Equipment (EVSE) equipped with advanced features like Smart metering, Cellular capability and Network

connectivity capable of fast charging or slow charging of electrical vehicles, along with associated upstream electrical infrastructure and conforming to National or International standards in force.

EV Public charging stations, identified to be installed as in Para 2 and as defined in Ministry of Power's revised guidelines/standards dated 1st October, 2019,

Long Range/Heavy Duty EV Charger: At least one charger of minimum 100 kW (200-750 V or higher), each of different specification if more than one, (CCS/CHAdeMO or any fast charger as approved by DST/BIS for above capacity)

It is advised that, where feasible, charging stations may be connected with renewable energy source of required capacity, as per MNRE guidelines, so as to ensure grid stability and green energy for electric vehicles. Such Public Charging Stations (PCSs) may also be connected to the Grid to ensure round the clock operation.

The selected agency for the development of charging station has to tie up with at least one real time EVSE Network Management Software Platform Provider to enable advance remote/online booking of charging slots by EV owners. Such real time information to EV owners should also include information regarding location, type, the number of chargers installed, cost of charging, available slots, etc. (cost has to be borne by the entity itself)

Terms & Conditions:

1.) Monthly License Fee

In lieu of the land/space provided by the MCD through HITES, you shall pay to MCD an amount of Rs. 1.00 per KWh of energy dispensed for charging of electric vehicles towards the rental charges for the land and support provided by MCD. The energy (KWh) as recorded by State Discom tariff meter shall be utilized for determination of the above calculations.

If the required **Space** is more than three ESC **then** Rs. 2000/- will be levied extra per ECS per month.

Calculation of cost of 1 ECS (equal to 12.5 sqm) =

Monthly License Fee (MLF) of parking site divided by Equivalent Car space (ECS)

HITES may revise fees after 5 years based on MCD guidelines on mutually agreed terms and conditions. HITES through MCD will provide land/space for the installation & operation of **EV charging station and battery swapping station** as per MOP guidelines and standards and subsequent amendments thereof. The land/space allotted may be used for 2/3/4 wheeler vehicles or as per requirement. Any modification in requirement of space may be mutually decided in subsequent stages depending upon revenue generation.

Non-Payment of Monthly License Fee:

The payment of license fee shall be on monthly basis, in advance, by the 5th day of each calendar month. Non-payment of monthly license fee and other dues within the prescribed date will constitute breach of the terms of permission and render the permission liable to be revoked. Besides, any delay will attract payment of simple interest@12% per annum on the amounts of permission and other dues remaining outstanding after the due date including the arrears. Interest shall continue to accrue till the monthly license fee and other dues are fully paid. Such Interest shall be charged for the full month if the payment of monthly license fee and other dues is not made by the due date with arrears, if any. In case, payment remain outstanding for a maximum period of 3 months the permission granted shall stand terminated.

2.) Key responsibilities:

a. HITES through MCD

- i. MCD will provide bare space for installation of electric vehicle charging station and battery swapping station on land/space owned or managed by MCD and on PWD roads (which were transferred to PWD for maintenance), in the jurisdiction of MCD.
- ii. Necessary system re-enforcements with parking concessionaire and other authorities for Installation of PCS as and when required, at mutually agreed Locations.

b. Responsibilities of concessionaire (Public Charging Station operator)

- i. Procurement of Changing Units
- ii. Procurement of Related Infrastructure
- iii. Undertake location assessment in association with MCD and utility
- iv. Apply for power connection
- v. Foundation for placing of Charging Units
- vi. Electrical earthing for Charging Units
- vii. Payment gateway
- viii. Central Management System
- ix. Paint jobs required for changing stations
- x. Canopy for charging units, barricading and demarking EV charging slot
- xi. Start-up, testing, and commissioning of each Charging Unit and Related Infrastructure.
- xii. SLD Charges, cost associated for service cable connection for electric vehicle infrastructure
- xiii. Create awareness of Charging Units amongst general public
- xiv. Any applicable taxes/levels will be paid by you as applicable by the law in force

3.) Co- branding and Advertisement:

The **concessionaire** have the right of advertisement and branding activities in & around of or peripheral to Charging Units or Charging Hubs at the Location. The revenue from such advertisement and branding activities (if any) shall be shared between the **concessionaire**, HITES and MCD as per agreed terms. MCD will take 50% of the total invoice raised / earning based on the terms of allotment letter. The **concessionaire** will have to follow the guidelines contained in Outdoor Advertisement policy, 2017, DMC Act & Advertisement Bye Laws as amended from time to time. The unit area for advertisement / display will be decided as per the tendered rate/ approved rate of MCD or selling price of the advertisement by you, whichever is higher and as finalized by MCD. The revenue generated on this account will be deposited in an Escrow Account and will be shared between MCD, HITES and the **concessionaire**. Calculation of revenue from advertisement will be done on actual basis i.e. on the basis of total revenue earned on this account.

4.) Key Financial Matrics of the PCS Business:

The operating cost of the Structure of PCS is as below:

Cost of power consumption: The PCS operator has to pay cost of power and applicable surcharges and duties as approved by the respective state Electricity Regulatory Commission.

Capital costs: Capital cost of PCS includes costs related to the Equipment Installation of EV Supply Equipment (EVSE) and related infrastructure such as (CMS), meter and meter box, and accessories such Charger management System as canopy, LED screens, CCTV camera, barricading, etc.

Other operating costs: PCS operator needs to pay for several other services such as payment gateway charges insurance premium, etc.

5) Revenue Sharing: HIGHEST REVENUE OFFERED TO HITES (% Fee on earning i.e. say 10% on net earnings for example). Highest offer will be considered for award of work.

6.) Duration:

The permission granted by MCD shall remain in force for a maximum period of 120 months from the effective date of issue of permission letter.

7.) Indemnification:

The **concessionaire** shall indemnify, defend and hold HITES, MCD and any of its officers, members, directors, members, employees, and all of its and their successors and assign and against any and all, claims, liabilities, judgments including but reasonable attorney fees arising out of or incurred in connection with a breach of any representation, or covenant by the Concessionaire (you) including against any and all Damages from third-party Claims which arise out of or relate to: (i) Your (the Concessionaire) negligent acts or omissions, recklessness or misconduct; or (ii) the loss of life or any injury to persons or property due to conditions exiting at the property.

8.) Disputes:

In case of any, dispute arising on account of grant of permission by MCD the same will be subject to the jurisdiction of Delhi courts only. This award letter is governed by laws of India.

9.) Incubation Period:

You are requested to provide the required area for setting up Electric Vehicle (EV) Charging units and related infrastructure for EV Charging in aforesaid locations. You (The concessionaire) will be allowed a period of 110 days for procurement/ installation of charging infrastructure etc. The MLF will be payable after the Incubation period is over or from the date of installation & operation of Public Electric Vehicle Charging station etc. Whichever is earlier.

10) Termination Clause

This contract is valid for 10 years however can be terminated if the concessionaire fails to perform or violate any terms of the award letter or any EOI clause as referred above. HITES will issue a notice of 30 (Thirty) days to cure the default/ defect, failing which this contract shall stand terminated. HITES will be free to engage any other agency or agencies to complete the project.

11) HITES logo shall be put in all EVCS sites

12) The rates quoted will be valid for 2 years from the date of award of work and can be further extended on mutual agreement.
