Qualification Criteria

Existing:

3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year* should be at least 50% of the Tender estimated value (or equivalent in foreign currency at the exchange rate prevalent on date of tender opening) as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries."

Read as:

3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year* should be at least **30%** of the Tender estimated value (or equivalent in foreign currency at the exchange rate prevalent on date of tender opening) as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries."

All other contents of the tender enquiry including terms & conditions remain unaltered.

Note:

- i. In reference to the extension of bid opening date, the participating bidders who had submitted or are submitting their Bid security/EMD in the form of Bank Guarantee (BG) or FDR are instructed to extend the validity of their BG/FDR accordingly, i.e. required validity of EMD is to be kept in line with the extended bid opening date.
- ii. Prospective Bidders are also advised to check the website regularly prior to the closing date and time of online submission of bids.
- iii. Technical Compliance Sheet (v1.0) and Price Bid Format (v1.0) is uploaded on CPP Portal along with this amendment for necessary action of interested bidders. This will supersede any version uploaded earlier.
