- 2. To Prepare the tender document as per relevant public procurement rules by the Govt of India.

- 4. To finalise the schedule from concept to commissioning in consultation and concurrence from AllMS, Bhubaneswar

- 1.2 HITES is specialized for infrastructure development and procurement of medical equipment and devices in healthcare sector. HITES provide services in design, engineering and execution of construction projects. HITES is also specialized in providing procurement and consultancy services to the Government of India, State Governments and other institutions for procuring a range of healthcare and hospital products, equipment and devices. It is designated as a National Procurement Support Agency (NPSA). 3. CORRUPT OR FRAUDULENT PRACTICES


